



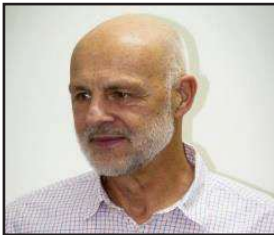

## Incorporated Associations | Financial Reporting

At the recent AGM there was a comment that the financial accounts were not accompanied by an ‘Audit Report’ but instead by an Independent Audit Review Report’.

In very general terms, an auditor’s report is a written statement made by an [external](#)

[auditor](#), stating that person’s opinion on whether a client’s [financial statements](#) comply with the applicable [accounting framework](#) and are free of [material misstatements](#). This report is included with the client’s financial statements when it issues the statements to third parties. The report is intended to provide assurance to users that the financial statements meet certain minimum reporting standards. Generally, audit reports are prepared to satisfy and comply with provisions of company law

The so-called Independent Audit Review Report is a report prepared by a qualified person to satisfy and comply with the financial reporting provisions of the *Associations Incorporation Act 1981 (the Act)*, the law which regulates incorporated associations in Queensland.

With effect from 1 July 2023 the financial reporting thresholds in that Act for non-exempt incorporated associations changed. These changes were enacted/legislated by the Queensland Parliament, and the Club is required to comply with them. A policy objective for these changes was to reduce the regulatory burden for incorporated associations.

Incorporated associations are now classified as large, medium or small depending on revenues and current assets.

A Large Association is an association with current assets of more than \$1 million or total revenues of more than \$500,000

A Medium Association is an association with current assets between \$300,000 and \$1million or revenues between \$150,000 and \$500,00

A Small Association is an association with current assets of less than \$300,000 or revenues of less than \$150,000

The financial accounts for the Club for the calendar year ended 31 December 2023 report revenues of \$118,515 and current assets of \$363,323. Accordingly, the Club is classified as a Medium Association for the purposes of the financial reporting provisions of the Act, as its current assets exceed \$300,000 (even though its revenues are less than \$150,000)

In fairly general terms, the Act provides that unless a Medium Association is required to have its accounts audited under another law (for instance the Australian Charities and Not for Profit Commission Act), then a medium association may now prepare a verification statement rather than an audit report. This statement must be prepared by an auditor, accountant or an approved person,  
 The Club is not required by any other law to have its accounts audited and accordingly the Management Committee must ensure the association prepares a verification statement, which states:

- (i) that an auditor, accountant, or approved person has examined the association's financial records; and
- (ii) that the association's financial records show the association has adequate bookkeeping processes in place to correctly record and explain transactions to enable a true and fair financial statement to be prepared; and
- (iii) is signed by the auditor, accountant or approved person mentioned in (i) ‘

The Clubs financial accounts for the calendar year ended 31 December 2023 presented to members at the AGM were reviewed by Mr Jason O'Connor CA. He is a member of Chartered Accountants Australia and New Zealand. As a chartered accountant he is qualified under the Act to review the Club's financial accounts.

The Independent Audit Review Report” he prepared for the information of members consists of 5 paragraphs. Mr O'Connor concludes that: *in his opinion the Arana Contract Bridge Club has bookkeeping processes in place adequately record the Associations income and expenditure and dealings with its assets and liabilities. Based on the review, nothing has come to my attention that causes me to believe that the financial report does not satisfy the requirements of the Associations Incorporation Act 1981.*

The Financial Accounts and Mr O'Connor's Report are available at the Club for inspection.

If you should have any questions do not hesitate to contact the Treasurer, Secretary or any other member of the Committee.

For those interested, the provisions relating to Financial Reporting for Incorporated Associations are in Division 2 of the Act.
